President's Remarks

We are looking forward to our 46th annual meeting, "Commemorating the Legacy of Jacques Maritain on the Fiftieth Anniversary of His Death," to be hosted by the University of Dallas from April 27-29, 2023. Do not forget to submit your paper proposal by January 1. I also want to thank our hotel host, the Spring Hill Suites Dallas DFW Airport East/Las Colinas Irving. (That's a mouthful, but since there are so many hotels in the area of DFW, these identifiers will indicate the correct branch.) The conference rate is \$139 per night. See the AMA website for a link to make reservations. Note. **however:** since the conference rate has been extended to us for an entire week, you need to specify the dates of your stay when making reservations.

Considering Maritain's legacy, we need to note that it is not only of Catholic interest, but also catholic in its interests. He wrote incisively not only about the difficult issues of contemporary politics, but also the ethereal eternal issues of mysticism, and of all manner of philosophical issues in between. Maritain himself, in *Existence and the Existent*, put his finger on what united all his intellectual endeavors: as a student of Thomism, he is motivated by the desire to inculcate an appreciation for the



"generosity of being." Indeed, this is precisely why Maritain's legacy is still of urgent relevance, for, as he points out, it is only this piety to being which can cure the intellectual diseases of our day. These admonitions might well have been written today:

We are here in the presence of the most significant privilege of that great zeal for being which animates Thomist thought and renders it so desperately necessary while at the same time so foreign and intolerable to the emptied, exasperated, ailing reason of our time. Thomist thought is a creator of unity; we cherish dispersion. It is a creator of liberty; we go in quest of any sort of collective yoke. It is a creator of peace; and violence is our preference. The ills that rend us are what we love most in the world. We do not want to be set free.... If [Thomas's] spirit and his doctrine tend to create unity in man it is always by virtue of the same secret-which is to understand all things in the light and the generosity of being.

Too many in our society, and especially in the academy, abuse the gift of reason to distort the truth, to sow discord, to try to gain partisan advantage. Indeed, philosophers, many following Nietzsche, have concluded preposterously that this is the only function of rational discourse. Our inquiries, then, are not merely exercises in academic nostalgia or sectarian apologetics; rather, they are called for by our duty to truth and our love of neighbor, for the sake of which we work to reveal the generosity of being in our midst. In this way, the philosopher's vocation is to serve, not an ideology, but rather that most generous Creator of being, God, by showing how all reality points back to Him.

Upon Maritain's death, Pope Paul VI eulogized his friend by stating that Maritain was a "master of the art of thinking, of living, and of praying." These are the only proper responses to the generosity of being: contemplating it in wisdom, fructifying it in love, and directing it back to God. It is this way of life that we commemorate in recognizing the legacy of Maritain at our next meeting.

Festschrift in Honor of Sr. Mary Prudence Allen, R.S.M.

In early 2017, the third and last volume of Sister Mary Prudence Allen's magisterial work, *The Concept of Woman*, was published by Eerdman's Publishing Co. of Grand Rapids, MI. This event marked the culmination of 40 years of sustained scholarly research and writing on Sister Allen's part.

In November of 2019, a conference was held in Sister Allen's honor in Saginaw, Michigan, the diocesan see in which the Motherhouse of the Religious Sisters of Mercy of Alma, Michigan – of which she has been a member since 1983 – is located. The papers given at the conference were written in view of the publication of a *Festschrift* in her honor, which has currently been recommended for publication at the first phase of review by a prospective publisher.

Sister Allen's work has many connections to the American Maritain Association. In addition to her three-volume *magnum opus*, Sister Allen has published a plethora of articles. In many of these, she explores in greater depth themes or philosophers presented in *The Concept of Woman*. In other articles, she has written extensively on Jacques and Raissa Maritain, as well as other exponents of the personalist movement of the 20th century, such as Edith Stein, Dietrich von Hildebrand, W. Norris Clarke, and, most particularly, Pope Saint John Paul II.

Sister Allen has been a member of the American Maritain Association from its beginnings and has been a regular presenter at its annual conferences. She was the recipient of the AMA's Scholarly Excellence award in 2014. She has won numerous other awards, most recently the Aquinas Medal of the American Catholic Philosophical Association in 2021. In 2014, she received the great honor of being appointed to the Holy See's International Theological Commission, on which she served until 2019.

The *Festschrift* itself also has many connections to the American Maritain Association. Many of the contributors are long-time members, including Michael Durham Torre, past president of the AMA and past general editor of the association's publications. Other contributors include John Hittinger, Mary Hayden Lemmons, and Thomas McLaughlin. Yet another contributor, William Sweet, was past president of the Canadian Maritain Association and will be an invited plenary speaker for the AMA meeting in Dallas in 2023. His contribution to the *Festschrift* on the relationship of bodily



integrity to the dignity of the human person is drawn from an extensive consideration of Maritain's writings on human dignity.

Sister Allen often would make presentations at philosophical conferences, including AMA meetings, to present research she had done for *The Concept of Woman* in order to solicit feedback from colleagues. In this way as well, the American Maritain Association played an important role in the development of each volume of the three volume work. Others whose work will be featured in the volume include Sarah Borden-Sharkey, Peter Casarella, Thérèse-Anne Druart, Patricia Pintado-Murphy, Deborah Savage, Susan Selner-Wright, Mary Catherine Sommers, Terrence Wright.

At this time, Sister Allen is completing the manuscript of a one-volume *Synthesis of The Concept of Woman*, with a thematic treatment according to St. John Henry Newman's criteria of authentic development from his work, *An Essay on the Development of Christian Doctrine.*

You can look forward to the publication of both the *Festschift* and the one-volume *Synthesis of the Concept of Woman* in the not-too-distant future.

"If I deem it inconceivable that intelligible objects are subject to an aging-process, or that a chronometric criterion suffices to evaluate our relationship with them, I believe on the other hand, that we must make room for a certain historical growth which creates-mainly as a result of the development of the positive sciences-ever new conditions of existence and exercise, an ever renewed *state* for philosophy. (Whether or not this state is a privileged one is another matter; it is, at all events, one which philosophy can reject only at the risk of becoming a mere museum piece.) I do not admit, however, that the essence of philosophy is changed on that account. And, it is my view that although Christian philosophy took form during the Middle Ages, its nature was not struck by an exclusively medieval, precopernican, precartesian, or preeinsteinian-in short prehistoric-stamp. Now that it has been freed, thanks to Galileo and Descartes, from the dead weight of that Aristotelian astronomy and pseudophysics which some still persist in confounding with its metaphysics, I believe it can take its place on the morrow (depending on its powers of assimilation) in a perfectly contemporaneous status."

In 2013, then president of the AMA, John Trapani, was contacted by Paulist Press; they planned to republish two of Maritain's classics, *Existence and the Existent* and *Approaches to God*, and they invited him to write the "Forward" to each of these books. Happily, he accepted their request, and he worked hard on this project. After receiving both of his essays, Paulist Press never contacted him again and John's repeated emails went unanswered. THE 46TH ANNUAL MEETING OF THE AMERICAN MARITAIN ASSOCIATION Thursday, April 27 to Saturday, April 29, 2023 Hosted by the University of Dallas, Irving, TX

April 28, 2023, marks the fiftieth anniversary of the death of Jacques Maritain. We therefore take this opportunity to reflect on the significance of Maritain's thought in his own day and its continued relevance for Catholic thinkers in ours. Like his great teachers, Aristotle and Thomas Aquinas, Maritain himself embraced a "supreme docility to the lessons of the real [that ground] the principles and the scale of values" (Degrees of Knowledge, xiv) in the full spectrum of intellectual inquiry, from science and politics to art and theology. Maritain's dedication to the unity of wisdom based in being is a model for contemporary scholars in their work to overcome both the groundless idealism of modern philosophy and the overspecialization that obscures the integrity of human experience.







Expertly compiled and translated by Matthew K. Minerd, these essays confront the difficulty of assessing the proper locus of conscience in moral theology—a difficulty as palpable today as when debates over casuistry and probabilism raged. Introduced by Minerd's own expansive overview of conscience, the volume comprises Merkelbach's "Where Should We Place the Treatise on Conscience in Moral Theology?" 

Gardeil's work in spiritual theology. The volume was originally published posthumously through the collaboration of Fr. Gardeil's nephew, Fr. Henri-Dominique Gardeil, OP and Jacques Maritain.

Although not well-known in the English-speaking world, Fr. Ambroise Gardeil, OP (1859-1931) was a Dominican of significant influence in French Catholic thought at the turn of the 20th century. Conservative theologians like Frs. Reginald Garrigou-Lagrange, OP, Michel Labourdette, OP, Jean-Hervé Nicolas, OP and many others hailed him as a careful expositor of the supernaturality of faith, a defender of the theological nature of rational apologetics, and a spiritual master.



Emmanuel Durand unties some of the knots that face us when we reflect on the God of biblical Revelation. In each of the essays gathered here, Fr. Durand sympathetically articulates the tensions and apparent contradictions experienced by contemporary minds as they strive to understand the revealed truth of God. A whole host of topics are covered in this volume: the Cross and the revelation of the Trinity; God's holiness and transcendence; divine immutability and the sorrow of a loving God; Divine Providence and human prayer; the fatherhood of God and eschatology; Christ's way of life; and many others.



For example, it is not the case that we are nothing but matter, souls, or parts of society. But many Catholic anthropologies have overlooked ways in which we are irreducible and so have not given an adequate account of the uniqueness of each human person. This book presents a philosophical portrait of human persons that depicts each way in which we are irreducible, with the goal of guiding the reader to perceive, wonder at, and love all the unique features of human persons. It builds this portrait by showing how claims from many strands of the Catholic tradition can be synthesized.

In showing how to synthesize various traditions' claims, the book also offers new solutions to a number of debates in Catholic philosophy. 





John Wippel's third volume dedicated to the metaphysical thought of Thomas Aquinas. After an introduction, this volume of collected essays begins with Wippel's interpretation of the discovery of the subject of metaphysics by a special kind of judgment ("separation"). In subsequent chapters, Wippel turns to the relationship between faith and reason, exploring what are known as the preambles of faith. This is followed by two chapters on the important contributions by Cornelio Fabro on Aquinas's distinction between essence and esse and on participation. The volume continues with articles on Aquinas's view of creation as a preamble of faith, Aquinas's much-disputed defense of unicity of substantial form in creatures, his account of the separated soul's natural knowledge. and Aquinas's understanding of evil in his De Malo 1. The volume concludes with an article comparing Bonaventure, Aquinas, and Godfrey of Fontaines on the metaphysical composition of angelic beings.

Most of these issues were disputed during Aquinas's time by some of his contemporaries, and the proper understanding of each continues to be debated by various students of his thought today. Wippel's purpose, therefore, is to help clarify our understanding of Aquinas's thought on each of these topics, a task that requires the careful analysis of primary sources and of secondary literature and attention to the relative chronology of his writing.
